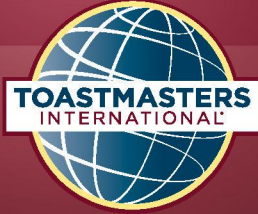

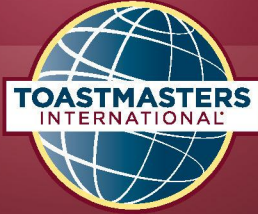
10. Present District Leadership Committee Report
